#### Northwest Industrial Park (NWIP)

Workforce Development Director, Kemsye T. Smith, provided an oral and written report updating the Board on ACT Work Readiness Certificate testing, county workforce data, Hinds County Workforce Nexus and Business Retention Visits for the month of September.

Ms. Smith highlighted repeated issues and concerns of businesses located in the Northwest Jackson Industrial Park. ## Hinds Solar, LLC

Executive Director, Tamika E. Jenkins, presented an Agreement to Pay a Fee in Lieu of Ad Valorem Taxes from Hinds Solar, LLC, a company looking to do business in Hinds County. Ms. Jenkins recommends that the HCEDA trustees recommend approval of the agreement to the Board of Supervisors.

**RESOLVED** to approve the recommendation to the Hinds County Board of Supervisors to approve the Agreement to Pay a Fee in Lieu of Ad Valorem Taxes from Hinds Solar, LLC.

#### **OLD BUSINESS**

#### **Billboards for Wynndale Industrial Park**

Executive Director Jenkins presented a 6-month proposal, including production costs, totaling \$8,538.00 from Newman Advertising Corporation for billboards near the Wynndale Industrial Park. Ms. Jenkins recommends accepting this proposal and using marketing funds from the FY 2023 Budget, once approved.

After further discussions, Ms. Jenkins will request and review the property's covenants and determine how signage on the property is addressed. No additional action taken.

## Purchase of Sky Cops for Northwest Industrial Park

Ms. Jenkins recommended that HCEDA purchase 2 Sky Cops for the Northwest Industrial Park in the amount of \$5,500 per camera, to monitor each end of the park. Further discussions included the suggestion of drafting an Inter-local Agreement with the city to address ownership, maintenance, and liability of the cameras in detail.

President Lackey appointed a committee to further discussion and develop a detailed outline of the Inter-Local Agreement with the city. The members include James Covington, Edderek "Beau" Cole, Yolanda D. McElroy, Executive Director Tamika E. Jenkins, and Legal Counsel Dorian E. Turner, if needed. Mr. Covington will contact Mr. Louis P. Wright to start conversations.

Ms. Jenkins requested permission to procure (one-time) lawn mowing service and clean-up of bulk items and trash for the Northwest Industrial Park with the written approval of the city.

Upon a motion by Jason E Owens, seconded by Edderek "Beau" Cole, with all trustees present voting AYE, it was

**RESOLVED** to approve the Executive Director to procure (one-time) lawn mowing service and clean-up of bulk items and trash for the Northwest Industrial Park pending the approval of the city, up to \$3,000.

#### **NEW BUSINESS**

#### Sponsorship for City of Jackson

Executive Director Jenkins shared that the City of Jackson's Jobs for Jacksonians will host a "Workforce Development Summit" in which the Authority will participate. Ms. Jenkins requested approval of a sponsorship of \$400 for water and snacks in support of this event.

**RESOLVED** to approve the Executive Director's request of a \$400 sponsorship for water and snacks in support of City of Jackson's Jobs for Jacksonians "Workforce Development Summit". The funds will come from the FY 2023 marketing budget line item.

Ms. Jenkins updated the board on other ongoing projects and a recap of the HCEDA Workforce Development Summit.
